# Statutes of the University of Lübeck on conducting selection procedures for applicants with foreign qualifications

# Section 1 Scope of application and general provisions

- (1) These statutes apply in selection procedures for local allocation procedures in the preliminary quotas in accordance with Section 5 (1) sentence 1 number 3 and Section 4 (7) sentence 2 in conjunction with Section 5 (1) sentence 1 number 3 HZG. They also apply in the selection procedure of the central allocation procedure in the preliminary quota in accordance with Article 9 (1) sentence 1 number 3 of the State Treaty on the Establishment of a Joint Institution for University Admission of 4 April 2019 (GVOBI. Schl.-H. p. 328) in conjunction with Section 12 (1) HZG.
- (2) All foreign applicants who do not have equivalent status to German applicants in accordance with Section 22 of the University Admission Ordinance of 4 December 2019 (NBI. HS MBWK Schl.-H. p. 56), last amended by the state ordinance of 5 July 2023 (NBI. HS MBWFK Schl.-H. p. 22), are included in the selection procedures.

## Section 2

### Preliminary quota selection procedure

- (1) The average grade of the higher education entrance qualification or the average grade of the prior degree qualifying for the degree programme is used as the selection criterion. The assessment recommendations of the Secretariat of the responsible Conference of the Ministers of Education and Cultural Affairs of the Länder Central Office for Foreign Education are used for this purpose.
- (2) The places to be allocated will initially be offered to applicants from the various countries of origin according to their level of qualification. If, after final allocation to all countries of origin, there are still places to be offered, these will be offered purely on the basis of qualification.

- (3) The average grade of the prior degree qualifying for the degree programme is improved as follows if the following criteria are met:
  - a) Proof of successful completion of a one-year preparatory programme at the University of Lübeck results in an improvement in the grade of the university entrance qualification
    - aa) by 0.3 points with a grade in the preparatory course of 1.0 1.3,
    - bb) by 0.2 points with a grade in the preparatory course of 1.4 1.9,
    - cc) by 0.1 points with a grade in the preparatory course of 2.0 2.5.
  - b) Proof of successful participation in one of the interdisciplinary courses in the winter semester and in the summer semester results in an improvement of the grade of the university entrance qualification by 0.1 points each.
