# DATA PROTECTION INFORMATION ON THE VOLUNTARY COVID RAPID TEST

### Participation in the voluntary COVID rapid test

#### **Purpose**

In order to carry out the voluntary COVID rapid test (hereinafter "COVID test"), we process your first name, surname and mobile phone number as well as the test result of the COVID test.

If your test result is positive, we will contact you by SMS at the mobile phone number you provided.

### **Legal basis**

The legal basis for processing your data to carry out the COVID test is your consent (Art. 6 para. 1 lit. a, 9 para. 2 lit. a DSGVO). You can revoke your consent at any time with effect for the future.

### **Recipients**

In principle, your data will not be passed on to third parties in connection with the implementation of the COVID test.

## Storage period

Negative test result: Your data will be destroyed immediately.

Positive test result: Your data will be destroyed immediately after you have been contacted.

#### **Your rights**

If your personal data is processed (collected, recorded, stored, evaluated, modified, read, queried, disclosed, disseminated, matched, linked, restricted, deleted, destroyed, etc.), you are a data subject within the meaning of the DSGVO. As a data subject, you have the following rights against any controller who processes your personal data:

- Information (Art. 15 DSGVO)
- Correction (Art. 16 DSGVO)
- Deletion (Art. 17 DSGVO)
- Restriction (Art. 18 DSGVO)
- Data portability (Art. 20 DSGVO)

If you believe that the processing of your personal data violates data protection law or your data protection rights have otherwise been violated in any way, please contact us. This will enable us to address your concerns. However, you also have the right to contact the Independent Centre for Data Protection Schleswig-Holstein https://www.datenschutzzentrum.de/meldungen or another data protection authority.
