to start at the earliest possible time or date. The professor will be based at the University of Music Lübeck and will spend half his/her time seconded to the Universität zu Lübeck. The endowed professorship will be for a fixed term of 5 years with the aim of being taken on afterwards as a civil servant for life.

The **University of Music Lübeck** (MHL) offers a meaningful and effective combination of practical musical study with modules on music teaching and music science in order to do justice to both the increasing relevance of its communicative role, as well as the development of the students as artistic personalities. Studying in the unique atmosphere at the heart of the Hanseatic City of Lübeck will become a formative chapter of your life, learning in a contemporary setting in period buildings with the benefit of a very individualised system of consultation and supervision. As Schleswig-Holstein's only university of music, the MHL promotes cultivating, developing and teaching the art of music.

The **Universität zu Lübeck** (UzL) is a university with a research profile that focuses on the three main areas of "Brain, Behaviour & Metabolism", "Infection and Inflammation" and "Biomedical Engineering". It is a partner to BioMedTec Wissenschaftscampus, Technische Hochschule Lübeck, the Research Center Borstel, two Fraunhofer Institutes and medical engineering firms. References for the professor's experience in the focus areas of "Brain, Behaviour & Metabolism" and "Infection and Inflammation" as well as the UzL's other research profile areas are expressly desired, especially with regard to involvement in the Deutsche Zentren für Gesundheitsforschung (German Centres for Health Research), the Cluster of Excellence *Precision Medicine in Chronic Inflammation* and other funded programmes.

A joint research focus area on "Hearing" between the three Lübeck-based universities - Universität zu Lübeck, Technische Hochschule Lübeck and the University of Music Lübeck (MHL) - is currently being set up.

The position includes teaching duties of 12 hours per semester week (SWS) in accordance with the federal state regulations on teaching duties at universities (Landesverordnung über die Lehrverpflichtung an Hochschulen).

Applicants must meet the requirements defined in Section 61 (1) to (3) in conjunction with (5) of the Schleswig-Holstein Higher Education Act (HSG).

Requirements for the position:

- Completed relevant specialist medical training with licence to practise in Germany
- Habilitation (postdoctoral lecture qualification) or equivalent qualifications
- Expertise in cross-departmental information and induction events on the subject of musicians' health/musicians' medicine
- Experience in musicians' medicine and corresponding consultation skills

- Teaching experience
- Direct experience of music and music studies as well as experience in physical techniques are desirable
- High degree of willingness to participate in interdisciplinary networking, in particular research on musicians' health, and collaboration with other disciplines and cooperation partners

Tasks:

- To represent the discipline of Musicians' Health in lectures and consultations at the MHL in degree programmes and advanced training
- To establish cooperation between the universities and partners in the Hanseatic City of Lübeck, such as music schools and orchestras
- To participate in collaborative research projects relating to the above-mentioned research focus areas at the MHL and UzL
- To establish and conduct a consultation session for musicians' health for students and other groups at the MHL as well as within the framework of university outpatient clinics at the University Medical Center Schleswig-Holstein (UKSH)
- To collaborate in academic self-governance

The university is committed to the employment of people with disabilities. Therefore, severely disabled and equivalent applicants with the required aptitude will be treated preferentially. The university aims to increase the proportion of female professors and therefore specifically requests women with the necessary qualifications to submit an application.
